The above is a package fee, and includes re-choreography, use of our costumes, technical support and In instances when a single act is required, please refer to MICE rates.

EXCLUSIVE TOPLESS SHOW - Extra Details

Management may consider EXCLUSIVE SHOWING (for Topless Shows) based on:

ALL members of the group (maximum of 150 pax) to be above 18 years old.

Special tickets are to be issued, and controls are to be in place to avoid NON-GROUP members entry.
